Greetings from NQOCN, India.

As you are aware the Infant Mortality Rate (41 per 1000 live births) in Uttar Pradesh is very high. Uttar Pradesh has a Maternal Mortality Ratio (MMR) of 201 per one lakh live births. While there has been a significant improvement in under five mortality and infant mortality rates in the recent years, the reduction in neonatal mortality rate has been very slow (30 per 1000 live birth). Government of Uttar Pradesh is implementing various activities/programmatic interventions to address this important issue, and these include quality care provision during intra-partum and immediate postpartum, Facility based newborn care, Home based newborn care and Immunization. UNICEF office support Govt. of Uttar Pradesh in providing supportive supervision for strengthening of LaQshya (24 districts), FBNC and HBNC Programmes in all 75 districts for addressing high neonatal and maternal mortality.

In this context, UNICEF organized a 2 days' workshop on Quality Improvement for Maternal and Neonatal Healthcare Delivery System for Quality Consultants, LR staff and SNCU staff of UP in two batches, 29-30 January and 3-4 May 2019 with the technical support of NQOCN, India. As a further step in the same direction, it is planned to optimally utilize the knowledge gained and implement QI activities in the facilities, NQOCN will conduct mentoring visits to the selected facilities along with the UNICEF and NHM Quality Consultants of NHM from neighbouring districts.

NQOCN team will conduct the onsite mentoring visits to the district hospitals of Shrawasti, Balrampur and Sonbhadra in teams consisting of 3 coaches for each district (one nurse mentor, one QI doctor coach and one QI Obstetric Coach). The team will be accompanied by UNICEF and NHM Quality Consultants of NHM from neighboring districts. The onboard team will be conducting onsite mentoring for the aforementioned districts at a frequency of 4-6 weeks (total of 3 visits till Dec 2019). The teams will initially undertake to capacity build the DH teams in QI and undertake one demonstration LaQshya QI project which will be conducted over 8-10 weeks and sustained for 4 weeks during the course of this project. This will serve to build the capacity of teams in conducting the 6 QICs as envisaged in the LaQshya program.

The main activities in each onsite visit will consist of :

- Records reviewing as per the need of the project
- Solving problems through QI tools (POCQI)
- On spot skill building of staff (Mentoring/Coaching)
- Data analysis (using easy to learn QI tools like time series charts, fishbone etc)
- Report writing (at the conclusion of the first project)
- Measuring improvements using process and/or outcome indicators as defined by the participating teams.






