Renewal of Research Contract No. 17642/R0

Reference is made to Research Contract No. 17642/R0 between the IAEA and the Maharishi Markandeshwar University which entered into force on 26 December 2012.

The IAEA desires to renew the Contract No. 17642/R0 for the period 11 December 2015 to 10 December 2016 with the following modifications:

**1. Programme of Work**

1. A single computer program for the calculation of the radius parameter and hindrance factor (merging of ALPHAD and RAD) will be prepared and submitted to the IAEA for dissemination as part of the Analysis Codes used for Nuclear Structure and Decay Data evaluations for the Evaluated Nuclear Structure Data File (ENSDF).
2. The existing table of Magnetic Rotational bands will be updated taking into account all the newly available data.
3. The earlier table of radius parameters produced by Alkovali in 1998 (1998Ak04) will be updated.
4. The evaluation of mass chain A=226 will be finalized and submitted for review.
5. Efforts to further strengthen the data evaluation activity at Maharishi Markandeshwar University, Mullana, Ambala (India) will be continued.


The above work will be done in consultation with other Data Centres, in particular with Dr. B. Singh (McMaster Univ., Canada), Prof. A.K. Jain (IIT Roorkee, India), Dr. J.K. Tuli (NNDC, BNL, USA), and Dr. G. Mukherjee (VECC, Calcutta, India).

**2. IAEA's Contribution**

The IAEA shall pay a sum not exceeding € 4 000 (Four Thousand).

**3. IAEA Financial Obligations**

The financial contribution from the IAEA pursuant to Clause 2 ("IAEA Contribution") of this Renewal shall be paid to the Contractor in two installments as follows:

(i) An initial payment equivalent to € 2 000 (Two Thousand) shall be paid within one (1) month from the entry into force of this Contract.

(ii) A final payment equivalent to € 2 000 (Two Thousand) shall be paid upon the completion of the Research Project and on the certification by the appropriate officer of the IAEA for the Research Project that the reports required under Article 3("Reporting") of this Contract have been received in due time and accepted by the IAEA.

If, under this Contract, the Contractor requests partial or total payment by the IAEA to a third party, this shall be specified in Annex B "Bank Information Form", which shall be signed by the duly authorized representative of the Contractor and by the third party receiving payment on behalf of the Contractor.

Any payment to a third party named as Payee in Annex B "Bank Information Form" shall constitute a settlement of the financial obligations of the IAEA to the Contractor under this Contract.

The Parties may provide through an exchange of letters made pursuant to this Contract that a part or parts of the payment to be made by the IAEA under this Contract shall be used for a particular purpose. In that case, the part or parts of the payment shall be used only for the prescribed purpose.


