1. Mr. Kishan Shandilya, a student of BBA. LL.B. 3<sup>rd</sup> year of Department of Law dropped a complaint on Anti-Ragging Portal of MM(DU), Mullana on March 8, 2023. After a preliminary interaction done with the students on March 9, 2023, the pre-notified enquiry committee sat for investigation on March 13, 2023,
2. After enquiring the matter, it came to notice that Mr. Shubham, Mr. Ashan (Named in complaint as Eshan) (B.Tech CSE 4<sup>th</sup> Year) & Mr. Shivam (B.Tech CSE 3<sup>rd</sup> Year) were playing holi in the roof of their residence outside the campus and Mr. Kishan Shandilya (BBA. LL.B. 3<sup>rd</sup> Year) was passing through the street. The accused were shouting with each other in the roof itself and were passing on each other in general which victim assumed that it was for him.
3. During investigation, as stated by the victim that it was a mere misunderstanding and pre judgemental interpretation on his end. The victim named Kishan Shandilya, also admitted that in heat of the moment, he sent a complaint on Anti-ragging Portal. Now, he voluntarily gave in writing for the withdrawal of his complaint (Refer Annexure-1) as the matter does not pertain to ragging. Mr. Shubham, Mr. Ashan (Named in complaint as Eshan) & Mr. Shivam, all three accused submitted their apology in writing & affidavit stating not to repeat this undesirable activity in the future. (Refer Annexure-2,3,4,5,6,7)
4. On the basis of enquires and investigation, it has been resolved that it was not an instance of ragging in any way and it was sort of misunderstanding between the students of both sides which amicably resolved.
